#### TSC Lunch N' Learn Series



### **Public Policy Update**

**Get up to speed on another busy season for important truck safety issues!** by Zach Cahalan

- On July 26th, the DC Court of Appeals <u>denied our petition</u> filed against the Federal Motor Carrier Safety Administration's (FMCSA) final Hours of Service (HOS) rule. We appreciate Advocates for Highway and Auto Safety and the International Brotherhood of Teamsters for helping lead this fight for safety alongside us. Our new <u>Driver Fatigue Factsheet</u> helps explain why this rule harms safety efforts.
- The National Highway Traffic Safety Administration (NHTSA) took action to fulfill some of its underride guard-related mandates in the Infrastructure Investment and Jobs Act (IIJA). First, they announced a rear underride guard final that <u>utterly failed</u> to meet both our expectations and that of Congress. TSC most certainly will be submitting a petition to NHTSA requesting they reconsider this rule. Secondly, NHTSA accepted nominations for a newly formed Advisory Committee on Underride Protection. TSC is fortunate to have multiple nominees put forward for this Committee and hopes to have our nominees accepted to inform this important work.
- July 26th was not kind to us! Regrettably, FMCSA also began accepting motor carrier applications to participate in the Safe Driver Apprenticeship Program (a.k.a. Teen Trucking Pilot Program). Due to TSC pressure, FCMSA did modify the program, such as forcing carriers to formally register with the Department of Labor as Apprentice Providers as well as adding a new requirement for rear driver-facing cameras for drivers that must be used during their training. We remain staunchly opposed to this program
- and will be closely monitoring it.
- In other FMCSA happenings, the agency issued a <u>Supplementary Notice of Proposed Rulemaking</u>
  (SNPRM) to require speed limiters in CMVs. TSC strongly supports this effort and filed joint
  comments with Advocates for Highway and Auto Safety in the open comment period.
- On June 8th, Robin Hutcheson advanced out of the <u>Senate Commerce</u>, <u>Science and Technology</u> <u>Committee</u> and awaits full Senate confirmation to become FCMSA Administrator. The position has lacked a Senate-confirmed Administrator for 3 years. Unfortunately, on Aug 12, **Dr. Steven Cliff** announced his resignation and pending departure as NHTSA Administrator.
- Legislatively, the House Transportation and Infrastructure Committee <u>advanced H.R. 2187</u>, the Truck Parking Safety Improvement Act. TSC supports efforts to <u>increase truck parking</u>, a known safety issue, as long as those efforts do not compromise appropriated funding for other important needs. Additionally, Rep. Mast (R-18-FL) introduced <u>several anti-safety bills</u> that would seriously compromise safety if anyone took them seriously. Efforts to roll-back truck size and weight requirements will likely increase if the House or Senate switches hands after November elections.
