TSC VOLUNTEER SPOTLIGHT: BRIAN GOGGIN



Brian is new to the Truck Safety Coalition this year. Last year, Brian's mother, Karen, was killed by truck violence when a semi failed to slow in a construction zone and struck his parent's vehicle from behind.

Brian is native to Washington, DC and works at the Arlington Partnership for Public Housing where he helps create new multifamily subsidized housing in the Washington, DC area.



Brian attended Sorrow to Strength this past year and was blown away by ALL of the issues negatively affecting truck safety in this country. He took it upon himself to raise awareness to this overlooked need and synthesized multiple fact sheets into one compelling editorial post in Greater Greater Washington online. TSC shared his post on Facebook and Twitter and it was the HIGHEST read tweet of the month!



Brian went on to share his story to Senator Tammy Duckworth this November. Senator Duckworth is known for her staunch support of AEB in CMVs, something which likely would have saved Karen Goggin's life. With his newly acquired expert truck safety knowledge, Brian also shared with the Senator additional needs to the cause of truck safety on our roads.

Public Policy Update

Get up to speed on important truck safety issues!

- Underride Activity

TSC filed a petition with NHTSA urging them to reconsider their final rear impact guard rule, which fell substantially short of what Congress requested of them in the Infrastructure Bill. Additionally, TSC nominated volunteers to serve on the Advisory Committee on Underride Protection and expects those announcements to be made soon, hopefully before the end of the year.

- Featured Public Comments

TSC makes a point to file comments on any relevant opportunities from DOT, NHTSA, and FMCSA. This practice helps remind federal policymakers we are collectively keeping a close eye on them and this can sometimes result in positive change. In October, TSC's comment helped encourage FMCSA to end the COVID-19 nationwide exemption to Hours of Service.

Recently, TSC was encouraged to see FMCSA issue an Advance Notice of Proposed Rulemaking seeking to adapt and expand Electronic Logging Device (ELD) requirements to make them far more effective. TSC also took FMCSA to task for not making more meaningful use of the Drug and Alcohol Clearinghouse System to keep known drug users from getting behind the wheel of a rig.

- Senate Confirms FMCSA Administrator

On September 22, 2022 Robin Hutcheson was confirmed by Senate voice vote to be the confirmed administrator of FMCSA. She is the 2nd confirmed Administrator of the Biden Administration, following the departed Meera Joshi. Ann Carlson continues to serve as NHTSA Acting Administrator following Steve Cliff's departure.

- Anti-Safety TRUCKS Act (S.4861) Introduced

Senators Kevin Cramer (R-ND) & Mike Rounds (R-SD) introduced legislation to exempt small businesses and other industries from Entry Level Driver Training Requirements. TSC was appalled and issued a letter to the full Senate Commerce, Science and Transportation Committee urging them to reject this anti-safety bill.

- Fond Farewell to Friends of TSC in Congress

Representatives David Price (D-NC-04) & Peter DeFazio (D-OR-04) are retiring at the end of the 117th Congress. Both Congressmen championed the needs of truck safety from the respective leadership positions, Chair DeFazio on House Transportation and Infrastructure and Chair Price on the Transportation, Housing and Urban Development Appropriations Subcommittee.


