Public Policy Update

It has been an eventful start to 2022 and the Truck Safety Coalition has no shortage of news to share with this amazing change-making community.

On April 25th, oral arguments were heard in response to the <u>petition</u> led by Advocates for Auto and Highway Safety and the International Brotherhood of Teamsters that was joined by CRASH and P.A.T.T. The petition is filed against the Federal Motor Carrier Safety Administration's (FMCSA) final Hours of Service (HOS) rule requirement changes made in June 2020. TSC is extremely concerned that the changes, specifically allowing "on-duty, not driving" time to count toward a 30-min break for drivers, as well as changes made to broaden the short-haul exemption, will make it more likely for fatigued drivers to be on our roads and unnecessarily put lives at risk. A <u>recording</u> of the oral arguments has been made available by the DC Court of Appeals. The three-judge panel asked hard questions of both sides of the issue and TSC and its partners hope the Court intervenes to vacate the deeply troubling and unsafe provisions of the rule. I encourage you to review this <u>editorial</u> from National Transportation Safety Board Vice-Chair, Bruce Landsberg, which succinctly outlines why these changes are dangerously problematic.

On April 6, FMCSA Deputy Administrator Robin Hutcheson was formally nominated by President Biden to be the FMCSA Administrator. She has a strong background in the transportation and safety sector and TSC looks forward to working with Robin to ensure truck safety needs are known and acted upon. TSC volunteers recently met with her this April to highlight the need to initiate congressionally mandated, yet long overdue rulemaking for a knowledge exam for new motor carrier operators as well as the need to increase the Commercial Motor Vehicle (CMV) minimum liability insurance requirement. TSC volunteers additionally met with National Highway Traffic Safety Administration (NHTSA) Acting Administrator Steven Cliff in March, emphasizing the need for action on speed limiters, and strong Automatic Emergency Braking and rear underride guard performance standards for CMVs.

Earlier this February, TSC submitted a <u>letter</u> to Department of Transportation (DOT) Secretary Pete Buttigieg pointing out the lack of concern for truck safety in the National Roadway Safety Strategy, specifically the complete oversight to require the usage of speed limiters in Commercial Motor Vehicles (CMVs). In response to YOUR advocacy, on April 27 FMCSA <u>announced</u> a rulemaking effort to require the use of speed limiters in CMVs!

Representative Andy Levin (D-MI-09) recently introduced <u>H.R. 7517</u>, the Guaranteeing Overtime for Truckers Act. This bill would fundamentally alter the trucking landscape by forcing truck drivers' time to be respected and paid for accordingly. Research has long indicated that when drivers are compensated fairly for the difficult work performed, safety outcomes improve accordingly. TSC strongly endorses this bi-partisan bill and is working to ensure a companion bill is also introduced in the Senate.

Lastly, TSC recognizes <u>PAM BIDDLE</u> for her phenomenal work in opposing exemptions to raise the truck weight in Georgia for the logging industry. Way to go Pam!!! In other state news, bills requiring underride guards have been introduced in Pennsylvania (HB2476) and New Jersey (A3205), both of which have strong TSC support. If you're from NJ or PA and would like to help support these important bills, let us know!

TRUCKS: THIS WEEK TONIGHT W/JOHN OLIVER



John Oliver recently produced an excellent segment investigating many of the structural problems with the trucking industry. With his trademark dry wit and accompanying explicit language, Oliver raises awareness to the absurd nature of it all and the dangers it poses to truck drivers and all roadway users, something our community knows all too well.

If you are comfortable with strong language and mature humor, we recommend you watch the segment and consider sharing it with your friends. It does a powerful job explaining what can be a complex issue in a digestible and approachable fashion.

WORK ZONE SAFETY WEEK

National Work Zone Awareness Week (NWZAW) was April 11 - 15. In its 22nd year, NWZAW is a nationwide public awareness campaign that spreads the message that everyone shares the responsibility for work zone safety. This year's National Work Zone Awareness Week theme was, "Work zones are a sign to slow down." In 2020, 857 people were killed in 774 fatal work zone crashes. 204 fatal work zone crashes involved at least one large truck. TSC participated in #GoOrangeDay, an opportunity to show support for work zone safety. This NWZAW, our volunteers honored their loved ones who were killed in work zone crashes involving large trucks.

RECENT TSC LUNCH N' LEARN EVENTS



In late March, we hosted a TSC Lunch N' Learn with Dr. Michael Belzer to discuss the myths surrounding the supposed truck driver shortage and its impacts to life safety. VOLUNTEER PROFILE: MELISSA STACKPOLE







Melissa Stackpole's husband, Jimmie Stackpole, was a truck driver for 15 years. On June 9, 2020, at 12:40am, Jimmie was nearing the end of his route when there was a collision between two semis in front of him. The first semi was fatigued and driving too fast for the rainy conditions when he lost control. The second semi failed to control his truck and hit the first truck. Jimmie was traveling at 45 mph when he attempted to avoid the collision, but debris from the initial crash led him to lose traction, so when he was hit from behind by another semi, he was pushed into the semi in front of him. In total, 6 semis and 2 vehicles were involved in the crash. Jimmie was pinned in the truck for 2 hours. He was pronounced dead in the ambulance on the way to the hospital. Despite Jimmie's commitment to safety for his entire career as a truck driver, he was surrounded by other trucks, owned by companies and driven by drivers that did not carry the same commitment. Since then, Melissa has been an active TSC member and truck safety advocate. Melissa has attended numerous TSC Zoom Nights and created a Facebook Fundraiser for TSC In honor of her husband Jimmie.
