DOT AEB RULE WILL PREVENT THOUSANDS OF TRUCK CRASH DEATHS AND INJURIES

Washington, DC — The Infrastructure Investment and Jobs Act required DOT to propose and finalize a new rule mandating lifesaving Automatic Emergency Braking (AEB) for Class 7/8 Trucks (26,000+ lbs.) Today, DOT released its Notice of Proposed Rulemaking (NPRM) and it goes well beyond the floor set by Congress and aims to require this proven, lifesaving technology on <u>ALL</u> newly manufactured Commercial Motor Vehicles (CMVs), including those over 10,000 lbs.

The announcement was greeted with enthusiastic support from truck crash victims and survivors exceedingly grateful for this lifesaving measure. The National Highway Traffic Safety Administration conservatively estimates that the rule would prevent 19,118 truck crashes per year, saving 155 lives and reducing 8,814 injuries annually.

"Automatic braking rules for cars and trucks are the most important safety improvements that could be issued. The United States is poised to join the European Union in mandating AEB on large trucks, which has had a comparable requirement since 2013. The rule also satisfies a long-standing recommendation made by the National Transportation Safety Board to DOT nearly ten years ago. Make no mistake, America is in the midst of a truck crash crisis. Since 2009, truck crash deaths have increased by 71% with 5,700 lives lost and nearly 155,000 injured in 2021 (the most recent year for which data is available). AEB will improve safety outcomes across the board and TSC urges DOT to use all resources at its disposal to expeditiously complete this rulemaking.
