Government Affairs Update

Vice Presidential Candidates on Truck Safety Issues



Minnesota Governor Tim Walz (D), Harris' Vice-Presidential selection, has been publicly supportive of sleep apnea testing for CDL holders. The NTSB cites driver fatigue as a major contributor in truck crashes. Obstructive Sleep Apnea (OSA) is believed to be pervasive amongst truck drivers in what the American Academy of Sleep medicine calls a **public health risk**. Governor Walz's position on sleep apnea is highly commendable and could save countless lives. Learn more about fatigue and OSA [HERE](#).

Ohio Senator JD Vance (R), Trump's Vice-Presidential selection strongly opposes the use of speed limiters in large trucks. Vance co-sponsored the Deregulating Restrictions on Interstate Vehicles and Eighteen-Wheelers (DRIVE) Act which **prohibits FMCSA from proceeding with speed limiter rulemaking**. Despite the fact that 20% of all fatal crashes occur at speeds 70+ miles an hour, Vance and some Members of Congress prefer to ensure that truck drivers operating in interstate commerce can recklessly speed, despite the clear and present danger to all roadway users. FMCSA estimates that hundreds of lives would be saved annually if speed limiters were required to be used. Learn more about the benefits of speed limiters [HERE](#).



FMCSA Administrator Revolving Door Keeps Spinning



Meera Joshi, Robin Hutcheson, Sue Lawless and now [Vinn White](#). In late June 2024, Vinn was appointed by DOT Secretary Buttigieg to serve as FMCSA Deputy Administrator, who will also serve as the FMCSA Acting Administrator.

Additionally, Vinn is also the USDOT Acting Chief Artificial Intelligence (AI) Officer. Prior to joining FMCSA, White was responsible for coordinating USDOT initiatives on emerging transportation technologies, including coordinating cross-departmental policies related to automated driving systems and surface vehicle-to-everything connectivity (V2X). NTSB Issues Report with Safety Recommendations to DOT

In the early morning of December 2022, a combination truck crashed into the rear of a bus traveling 65-70 mph, killing 3 and seriously injuring 9 others. The NTSB conducted an investigation its [report findings](#) this August. The Report includes several safety recommendations, among them: FMCSA regulations should be revised and require providers of Electronic Logging Devices (ELDs) to create audit logs, NHTSA should complete performance standards and protocols for forward collision avoidance (such as Automatic Emergency Braking) systems AND require the use of onboard video event recorders.

BARBARA GALGIANI – A CALL FOR CHANGE THROUGH GIVING

Barbara Galgiani's connection to the Truck Safety Coalition is deeply personal. In 2012, her nephew, Paul Katuszonek, was tragically killed by a truck driver who violated hours-of-service regulations. Paul, a dedicated police officer, cancer survivor, husband, and father to a one-year-old daughter, had his future stolen from him. The truck driver responsible was convicted of misdemeanor vehicular manslaughter and served only six months, while the company that employed him, Gold Star Foods, faced no criminal charges. Barbara has been fighting for change ever since, seeking to hold not only drivers but also their employers accountable for the dangerous practices that lead to crashes like the one that claimed Paul's life.

Barbara found the Truck Safety Coalition in her search for justice and solace and has been an active supporter ever since. This year, Barbara has been a tremendous advocate for matching gifts, generously encouraging others to support the TSC's mission. For Barbara, the legislative work of the TSC is most important, as she believes that changes in laws and regulations are crucial to preventing further tragedies.

Her commitment to raising awareness extends beyond her financial contributions. Barbara has used her personal networks to share the message of truck safety, inspiring others, including a business owner with a fleet of trucks, to take action and provide support. She continues to stay engaged with TSC by reading the newsletter, following updates on social media, and actively participating in campaigns.

Barbara's passion for change and her dedication to the memory of her nephew serve as an inspiration to us all. Her leadership in our matching gift efforts this year reminds us that together, we can make a real difference in the lives of those affected by truck crashes.

DONOR SPOTLIGHT: NORA'S JOURNEY FROM GRIEF TO ADVOCACY

Nora's connection to the Truck Safety Coalition (TSC) began after the tragic loss of her son, Dominic, in a preventable truck crash in May 2022. In the months following his death, Nora searched for ways to understand and address the dangers of underregulated trucks, leading her to TSC. After reaching out through the TSC website, she quickly received a response, and Dominic's story was soon shared on TSC's "Our Stories" page. Nora attended the Sorrow to Strength conference in September 2022, where she found a supportive community and the strength to begin her advocacy journey.

Since then, Nora has turned her grief into action, advocating for legislative change and public awareness of truck safety. She has visited Capitol Hill several times, hosted fundraisers in Dominic's honor, and even launched a postcard campaign urging lawmakers to improve safety regulations. She views her advocacy as a way to continue parenting Dominic by ensuring that his story contributes to saving lives.

Additionally, Gilead Sciences—her employer—has matched over \$10,000 in donations to TSC. Nora encourages others to explore donation-matching opportunities with their employers to maximize the impact of their contributions.





Truck Safety Champion Award Honoree: Congressman James Comer



The Truck Safety Champion Award was established in 2023 to recognize individuals or groups who have demonstrated exceptional leadership in advancing truck safety and the strategic goals of the Truck Safety Coalition.

Congressman James Comer (R-KY-1) has served Kentucky's 1st District in the U.S. House of Representatives since 2016. A staunch advocate for rural communities and public safety, Congressman Comer played a pivotal role in the passage of the Mail Traffic Deaths Reporting Act in the House of Representatives. His leadership in promoting stronger oversight and safety standards within the trucking industry, particularly within the United States Postal Service, has been crucial in protecting lives on the road. As Chair of the House Committee on Oversight & Accountability, Congressman Comer's unwavering commitment to truck safety reform exemplifies the power of bipartisan collaboration in making our roads safer for all.

Truck Safety Philanthropist Award Honoree: Nora Lopez


